



Compulsory Attendance Dues Charges

Parent and Caregiver Responsibilities

Ko e ngaahi fakamole ko eni´ kuo pau ke totongi ia´ o fakatatau ki he tu´utu´uni mo e aleapau´a e Potungāue Ako´ 2020 ki ha tokotaha´oku lesisita ki ha´apiako Katolika. Ko e ngaahi fakamole (Attendance Dues)´oku totongi he tokotaha kotoa pē´oku ako he ako´anga Katolika´i Nu´usila´ ni.

Ko e ngaahi totongi´´e tānaki ia´e he´apiako´ ko e fakafofonga´o e Taiosisi´. Ko e (Attendance Dues)´e´ave leva ia ki he Auckland Common Fund Limited, pe ko e kautaha kuo fa´u´e he Taiosisi Katolika´ ke nau tokanga´i.

- I he taimi na´a´ ke lesisita ai ho´o ki´i ta´ahine´ ki he´Apiako Katolika´, na´a´ ke loto lelei ke ke tali pea fakamo´oni te ke totongi ki he ngaahi Attendance Dues, pea mahino ko e ngaahi totongi ko eni´ ko e taha ia e ngaahi tu´utu´uni ki he lesisita ho´o ki´i ta´ahine´.
- E lava pē ke ke totongi kakato he kamata´anga e ta´u´, pe ko ha´o totongi fakakongokonga (uike, fakauikeua, māhina pe fakateemi)
- He´ikai ke lava ia ke ke toki totongi pē he faka´osinga e ta´u´.
- E lava pē ke ma´u atu ha foomu ki ha ngaahi fāmili´oku nau faingata´a´ia fakapa´anga, tautefito kia kinautolu´oku fakamo´oni mei´ he Pātele´. Ko kinautolu e ala tali ki he tokoni ko eni´, ko ha fa´ahinga pē´oku nau totongi´i ha totongi te nau malava´.
- Ko kinautolu´oku te´eki ke´osi hono totongi´,´e tuku atu leva kinautolu´e he Potungāue´a e Taiosisi Katolika´ ki he Debt Collection Agency ke nau hoko atu´enau ngāue´.
- Kapau he´ikai lava´o totongi´a e ngaahi (Attendance Dues)´e lava ke fakamālōlooi´atu ho´o ki´i ta´ahine´ he´apiako´.
- Ko e aleapau ko eni´´oku fakamālohi´i fakalao, pea ko e tokotaha na´e fakamo´oni ki he aleapau ko ia´´oku mo´ua ke ne totongi.
- He´ikai lava ke tuku ki ha tokotaha kehe ke ne hoko atu e totongi´, kae´oua leva ke na felotoi kuo´ na tali ke fakamo´oni ki ha tohi aleapau fo´ou.
- Ka´i ai ha palopalema´e hoko´i he vaha´a´o e ongo mātu´a´,´e kei tauhi pē´a e fakamo´oni mo e aleapau na´a´ na fakahoko he kamata´anga´.
